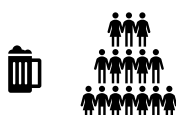


Village Hall Committee Events for High Kelling Residents and Friends

Clerk and Councillors

The Parish Council Meeting took place on 19th September. The Parish Clerk Jane Wisson has recently decided to resign having reconsidered the requirements of the role and did not attend the Meeting. We have been able to appoint a locum clerk for the remaining 3 months of the year. Gemma Harrison, who was previously the Parish Clerk at High Kelling and is now the Town Clerk at Holt, has kindly agreed to assist until we are able to appoint a new Clerk. We are very grateful to Gemma who has agreed to help at such short notice. An advert for the Clerk's role appears in this edition of the Parish Chronicle.



In due course we will be looking to co-opt up to an additional three Parish Councillors to bring the numbers up to nine. If any villagers would be interested in applying to be a Parish Councillor, then please let me know. I would be very happy to discuss this with you. It is not an onerous role, no previous experience is needed but it is a great way to contribute ideas as part of a positive and friendly team.

We were pleased that our District Councillors Eric Vardy and Martin Batey were able to join us at our recent meeting and very helpfully contributed their thoughts and ideas to assist High Kelling.

Highways matters

Members of the Parish Council will be meeting later this month with Steve White, Highways Engineer at Norfolk County Council, to discuss speed reduction and road safety on the A148 in High Kelling. The Speedwatch team are also looking to increase their presence by using different locations and carrying out the speed checks at different times of the day.

During August I attended a SNAP Meeting, and although there were no police issues affecting this village, I took the opportunity to request further police presence in respect of speeding. I was assured this would continue to happen.

Autumn village litter-pick and tidy-up

On Sunday 15th October we are asking for volunteers for the half yearly litter pick and path clearance. I am grateful to David Carter and Patrick Kelly for agreeing to organise this again. Although we will be trying to clear some of the footpaths where there is an accumulation of debris, we do also need to rely on individual householders to cut back overgrown hedges and clear the footpaths particularly in situations where

the footpath is narrow. If anyone with a property on the A148 is unable to keep the footpath clear or needs help then please let me know.

Full Fibre Broadband

Last month I raised the issue of residents registering their interest in Full Fibre Broadband. We are currently waiting to hear back from both Openreach and Upp as to their intentions for extending Full Fibre Broadband to High Kelling. Anyone who is interested in obtaining an improved Broadband service is urged to register their interest with both Openreach and Upp if they have not already done so.

Remembering Gordon Lane

Following the sad death of Gordon Lane, there will be an informal gathering to remember him on Sunday 22nd October between 2-5pm at the Village Hall. A memories book will be available to sign and anyone is welcome to say a few words if they wish. There will also be refreshments. The post is for four hours per week and includes attendance at all Parish Council meetings and responsibility for the finances, funding and the Council's risk management. Candidates should have book-keeping skills, communication, IT and organisational skills. Pay will be in line with SCP10 (£12.28) – SCP15 (£13.45) depending on experience and qualifications. High Kelling Parish Council Parish Clerk & Responsible Finance Officer

Overall Responsibilities

The Clerk is the Proper Officer of the Council and as such is under a statutory duty to carry out all functions, and in particular, to serve or issue all notifications required by law. The Clerk will be responsible for ensuring that the instructions of the Council in connection with its function as a Local Authority are carried out. The Clerk is expected to advise the Council on, assist in the formation of, overall policies to be followed in respect of the Authority's activities and in particular to produce all information required for making effective decisions and to implement constructively all decisions. The Clerk is also the Responsible Officer for the Council.

Specific Responsibilities

The specific responsibilities of the role are:

- To ensure that legal, statutory and other provisions governing or affecting the running of the council are observed.
- To prepare in consultation with the Chairman, agendas for meetings of the Council and ad hoc committee meetings as required; to attend such meetings as required; to prepare minutes for approval.
- To receive correspondence and documents on behalf of the Council and to deal with correspondence or documents or bring such items to the attention of the Council.
- To issue correspondence on the instructions of, or in accordance with the known policy of, the Council.
- To issue notices and prepare agendas and minutes for the parish meeting and to implement the decisions made at the assemblies.
- To attend all meetings of the council and its committees. (Meetings of the Council are held monthly.)
- To ensure that all financial activities of the council are conducted and maintained according to “proper practices” as identified in Governance and Accountability March 2018 and as required by the Accounts and Audit Regulations 2015.
- To ensure that the Council’s obligation to ensure its property etc. are properly met.
- To study reports and other data on activities of the Council and on matters bearing those activities. Where appropriate, to discuss such matters with administrators and specialists in particular fields.
- To draw up both on his/her initiative and as a result of suggestions by councillors’ proposals for consideration by the Council and to advise on practicability and the likely effects of specific courses of action.
- To manage all functions of the Council on those activities.
- To monitor the implemented policies of the Council to ensure they are achieving the desired result and where appropriate suggest modifications.
- To have delegated power from the Council to act as the Data Protection Officer for the Council.
- To act as a representative of the Council as required.
- To prepare, in consultation with the Chair, press releases about activities or decisions of the Council.
- To maintain records and the Website of the Council.
- To attend training courses on the work and role of the Clerk as required by the Council.

News from Your Village Hall Committee

Hall usage

We are pleased to report use of the Village Hall by activity groups has returned to pre-Covid levels and we have hosted several private group events, including a children's birthday party and a wedding reception. Hosts have expressed their appreciation of the facilities, as well as both the cooperation and support afforded by members and supporters of the Hall Management Committee.



Summer Barbecue

The Hall Committee and villagers have expressed their thanks to those involved in putting on the Village Hall Summer Barbecue on Sunday 3rd September, notably Sean and Nikki Doran who provided and prepared all the food. The event was attended by about 60 people who enjoyed the social event in a convivial al fresco environment. Yes, we were indeed fortunate that the weather changed for the better on the day.

Subsequently, the Committee considered some ideas to help improve future such events. Of note, one justifiable complaint about the level of publicity for the Barbecue had been received by email from a villager who only became aware of it after the event. The problem was acknowledged and discussed at length at our subsequent committee meeting. Noting data protection issues to be addressed, it was agreed that we should seek to use the existing Pub Night e-mail circulation list as a base for improving communications with villagers. This could be achieved by either:

- (a) Informing recipients of the existing mailing list that we intend to widen the scope of these communications to inform them of Trustee-led events at the Hall, and for them to inform us if they want to opt out of continuing to receive e-mails; or
- (b) Setting up a new dedicated HKVH-styled email account for this purpose, preferably as a no-repl account, if possible. Setting up such an account would provide resilience around the ability of other Trustees to send out communications if required, with password-protected access.

The Committee will set out to expand the mailing list by drawing attention to the existing list and inviting others to join it.

Christmas Fair

Sadly, even though the event was successful last year, the Committee reluctantly agreed not to hold a Christmas Fair in 2023. This decision was reached after considering the list of the tasks and workstreams involved and it was felt that there being fewer trustees than in previous years, all with other commitments, and bearing in mind the overall nature of the task, we had to be realistic about our capacity to organize and run the event. This decision was communicated to those potential stallholders who had made enquiries.

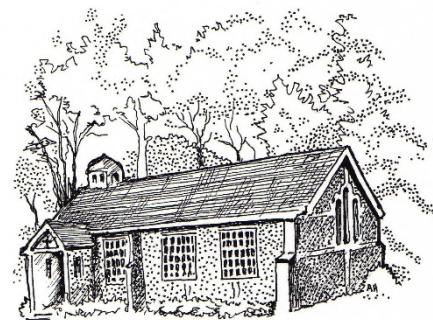

Dear Friends,

All Saints, Gift Day Saturday 4th November 2023

All Saints Church remains open every day for private prayer and to welcome visitors, and there are two public acts of worship each week. The church is also available for the occasional offices of baptism, holy matrimony, and funerals. It is home to a small but committed community of faith who attend church regularly and are keen to serve their neighbour and maintain the church's presence in the village. But they need help to do so and especially financial help to keep the church in good repair and open to all.

We all feel the effects of the ongoing rise in the cost of the living, even the Church. Last year our church collections and donations were down by 15% on the previous year, and after meeting our financial commitments for the year (£11,976) we ended the year with a deficit of just over £1,500.

We were able to carry this deficit because of our reserves. But this cannot continue and at present our weekly income does not meet our weekly expenditure. We are spending our reserves each week. Therefore, once again, I appeal to the wider community in High Kelling to help us maintain the Church's presence. We receive no direct funding from the Church commissioners and are dependent on the generosity of individual-giving. Would you please be able to help us to keep All Saints Church open to all?

Your donation no matter how small is very much appreciated and is gratefully received. If you can, please return the enclosed gift day envelope c/o Ann Alborough, 4 Pineheath Road, High Kelling Nr25 6QF or else return it in person on Saturday 4th November 10am – 12noon when, together with Ann, I will be sitting outside the Village Hall in Avenue Road in anticipation of your generosity. Thank you.

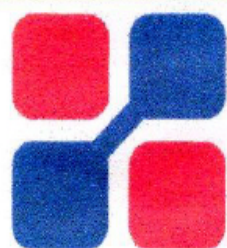
